The Ipnet Executive Board are delighted to announce the Bursary scheme to provide financial support to young scientists and clinicians wishing to attend and present their porphyria work at the International Congress on Porphyrins and Porphyrias. (http://icpp2024.com/)

Applicants should be aged under 40 years in 2024, and work on porphyria, in or with a recognised Ipnet centre, this centre must be a full or associate member of Ipnet. Funds are available to support up to 6 individuals. The bursary award is €1000. In addition, the Congress organizing committee have agreed to waive the registration fee for the successful applicants.
